

## SUPERINTENDENT OUTLINE FOR AMBASSADORS

### INTRODUCTION:

- Thank you. Introduce yourself.
- We are dialoging on issues impacting children in your area.
- Our organization prepares extensive letters and information for doctors, legal teams, school boards, on the current issues.
- We are working in collaboration with Superintendents, such as yourself, BOS at the county level, city council, school boards, and law enforcement.
- We also represent thousands of parents and children across the state including your area.
- We collaborate extensively with renowned experts, including epidemiologists, virologists, doctors, researchers, and other professionals.
- The parents, employees, and stake holders in your area have a lot of concerns. I hope to be able effective discuss them with you.
- Some of these issues I bring up will not surprise you. The tsunami of questions, concerns from parents surround: 1) CV Mandates/Requirements for School 2) Health Pass and 3) Vaccination Clinics Including Informed Consent problems.

### #1 MANDATES AND REQUIREMENTS

- Public and private measures are being considered to mandate experimental vaccination, to participate in certain public activities and functions of daily American life, including employment, in-person **school attendance.**
- Understandably parents have incredible concerns around the new shot being mandated or required for in person learning in your area.

### EUA “Authorization”

- It is not approved. It received approval for Emergency Use Authorization. It is still experimental and investigational. It is also still in clinical trials and clinical trials are not expected to be completed until 2022 or 2023.
- We are hearing from parents and teens that they feel they do not have a choice **to opt out or refuse.**
- **Teenagers are feeling incredible peer pressure** to get the cv vaccine, while it’s still experimental and under EUA authorization.
- **None of these treatments has been approved, but only granted emergency use authorization, hence cannot be mandated nor can informed consent be dispensed with.**
- Immunity caste system is developing, which is centered on getting the vaccine immunity or not.
- Do you have any intent to mandate or require the shot on the students?

### #2 ISSUE: VACCINE PASSPORT IS CONNECTED TO SCHOOLS: (in the form of Health Pass, COLOR, etc.)

LAUSD is using the Health Pass from Microsoft, is the preliminary to a digital vaccine passport for children.

Long Beach- COLOR Platform, is mass genomic surveillance platform. Parents are being forced to opt in for in person learning and by so doing, waive all legal and privacy rights. It is also funded by the NIH and Bill and Melinda Gates Foundation.

- Infrastructure in place goes far beyond the vaccine
- Digital footprint and humans/students become a digital commodity

- Where ALL things you need in life will be wrapped into the “health passport,” “vaccine passport,” and “verification systems.”
- It becomes a mechanism of control to illicit compliance by leveraging all your needs. (food, water, travel, banking, health, school, etc.)
- The “internet of things” . Smart cities encouraged to develop in Nevada with their own jurisdiction in the county, but outside of the county jurisdiction, rules, etc.

### **Putting the Burden on Schools to Initiate Health Passes, Digital Surveillance, etc.**

It controls people’s behavior, work, food, travel, health, entertainment, and free commerce. This is the gate to surveillance, monitor, penalize, rewards, with a targeted goal to conform.

**Example: Health “Orders”** in Santa Clara County and Los Angeles require all businesses, public government, volunteers, etc. to have a vaccine “verification” system, “proof” of vaccination”, with penalties and consequences for not following this order.

### **Can you do anything to protect the students from this?**

As Ambassadors, we are working with BOS at the county level, city council, school boards, and law enforcement. We are alerting them on these issues, educating about the issues, and work together to stop unlawful orders.

### **#3 VACCINATION CLINICS AND SCHOOLS**

There are rapidly approaching covid-19 “vaccine” clinics, for children ages 12 and up everywhere. Setting up these clinics at the school is unprecedented. Popping up all over the state at schools. Inappropriately allowing 11 and up to get the shot. Problems include:

- Expert Epidemiologist previously on IRB (review boards for clinical trials) alerted us the clinical trials on children should never have taken place and are violating CFR Title 21, Section 50.50 through 50.56
- Many clinics are giving vaccination without proof of parental consent other than a phone call.
- No parental ID required.
- Some counties are allowing 12 and up to consent WITHOUT parental consent. **Health “Orders”** in San Francisco allow 12 and up to get the new covid shot with OUT parental consent.
- Informed Consent is not fully being given regarding the risks/benefit for children.

### **INFORMED CONSENT AND INJURIES**

We are getting numerous complaints from parents that ***Informed Consent*** is not being given.

- They are being told and marketed to that the shots are approved and safe. They do not realize they are EUA authorized. and not disclosing it’s still in clinical trials and not currently FDA licensed.
- All the treatments being marketed as COVID-19 vaccines, are still in Phase III clinical trials until 2023 to 2024 and hence qualify as medical experiments. People taking these treatments are enrolled in clinical trials.
- CDC advisory board authorized co-administration with other shots at the same time, with no safety data on co-administration for children.
- Parents are unaware of the injury reports, which currently is at **5888 Deaths, 329,021 Injuries**,(as of June 4, 2021) with a 3-month backlog.
- There have been more deaths from COVID-19 vaccines, as reported to the Vaccine Adverse Events Reporting System (VAERS), than deaths in the last 20 years from all vaccines combined.
- The trials have not proven that COVID-19 vaccines prevent infection or transmission.
- **Students are at nearly zero % risk of contracting or transmitting** this respiratory illness and are instead buffers which help others build their immune system. The overall survival rate is 99.997% .

**ASK:**

- 1) Continue and open dialogue with you as the Superintendent.
- 2) We would like ask you to share this information with your staff, employees, and parents.
- 3) We ask for your commitment that the school does not mandate the new vaccine on children in exchange for in-person education.
- 4) Ask for superintended to not set up digital health passes like LA and Long Beach or ANY kind of vaccine verification system.

**EXTRA NOTES IF NEEDED:**

**Risks involved with the covid-19 “vaccine”**

1. The death rate for covid-19 for children under 19 is 0.00003%.
